Notes: The DC CAS tests are administered to grades 2-10; some schools' DC CAS scores are listed as "N/A" (not available) because they serve students in grades other than grades 2-10. In-boundary participation rates were calculated as the percent of in-boundary students enrolled at the school out of total school enrollment SY2013. In-boundary participation rates are not displayed for public charter schools since they do not have a school boundary. Facility utilization rates were calculated by dividing building capacity by 2013 audited enrollment. School building capacities are from the 2013 Public Education Master Facilities Plan with some updates to include temporary space where plans were in place to convert that space permanently into the building. Facility utilization is not displayed for charter schools since consistent, uniform charter capacity data are not available.
