# **USDA Child Nutrition Programs**

DC Public Schools (DCPS) is proud to offer nutritious meals to support student learning and success. DCPS participates in the United States Department of Agriculture (USDA) Child Nutrition Programs and adheres to guidelines established by the DC Healthy Schools Act. Our schools participate in the USDA School Breakfast Program, the National School Lunch Program, the Child and Adult Care Food Program, the Fresh Fruit and Vegetable Program, and the Summer Food Service Program.

# School Meal Service during the Coronavirus Public Health Emergency

For school year 2020-2021, while the Covid-19 emergency virtual and/or hybrid learning model is in place, select school sites will be serving breakfast and lunch for pick up to DCPS students. One breakfast and one lunch will be provided per student, per school day. Parents or caregivers can pick up meals on behalf of their DCPS student(s). Student name, student ID number, and school name must be provided at the pick-up site. During the Covid-19 Emergency virtual and/or hybrid school learning, all meals will

be free for DCPS students.

# Meal Prices & Free and Reduced Price Meals

When full-time in-person, school learning resumes, the following meal prices will be in place: Breakfast: Free; Lunch: \$3.00. Contact your school administrator to learn about meal programs specific to your school.

Your student may qualify for free lunch through one of the following ways:

- 1. If your student attends one of the 86 schools participating in the Community Eligibility Provision Program (CEP); to see this list of schools, please visit the below web page or contact your school: <a href="https://dcps.dc.gov/page/community-eligibility-provision-cep-schools">https://dcps.dc.gov/page/community-eligibility-provision-cep-schools</a>.
- 2. At remaining schools, DCPS students may qualify for free meals if:
  - a. Students are in households receiving benefits from the Supplemental Nutrition Assistance Program (SNAP), the Food Distribution Program on Indian Reservations (FDPIR), or Temporary Assistance for Needy Families (TANF).
  - b. Students are foster children that are under the legal responsibility of a foster care agency or the court, or are homeless, migrant, categorically eligible, or runaway.
  - c. A Free and Reduced-priced Meal (FARM) application is submitted and approved based on the Federal Income Eligibility Guidelines.

All school-aged children in income-eligible households can receive school meal benefits regardless of a child's immigration status. ### Meal Payments

Submit payment for lunch meals in one of the following ways:

- 1. By paying with a credit/debit card at myschoolbucks.com, an online prepayment service, (there is a service charge of \$2.49 per transaction); or,
- 2. By sending a check or money order (student ID# **must** be included) made payable to the DC Treasurer to the following address:

Students will never be refused a meal or served an alternate meal selection if there are no funds in the student account. The meal will automatically be charged to the student account and will create a negative meal balance. Students with a negative meal balance are not identified in any way during meal service and will receive the same meal choices.

#### Negative Meal Balance

As a courtesy reminder, once a student's balance exceeds \$9.00 (3 charged lunches), household notifications are made via automated communications (calls, text, email). Automated communications will continue until the negative meal balance is paid. The aforementioned payment methods (online and check/money order) can be used to pay off negative meal balances.

As your student continues to eat lunch, meal balances will increase. You can manage the meal balance by loading funds to your student's meal account. Any unpaid meal balances will rollover into the next school year. Any payments made will first go to pay off the negative meal balance. Please note that negative meal balances do not delay a student's graduation. DCPS Food and Nutrition Services makes every effort to answer questions related to negative meal balances and repayment.

Automated communications are also used to remind families to complete FARM applications to ensure all students qualifying for free meals are made aware of the application.
