In accordance with Chapter 24 Subtitle 5-B, Section 2405 of the District of Columbia Municipal Regulations, DC Public Schools (DCPS) Comprehensive Alternative Resolution and Equity (CARE) team has completed its investigation of the above referenced grievance.
Grievance Issues
Based on a review of the information provided, the written grievance raised the following issues under the jurisdiction of this office:
 5-B DCMR 2405.2(e): Where a student is a victim of bullying or harassment, including sexual harassment. a. It was reported by that several students, including engaged in a "private parts" club.
These allegations fall under Title IX of the Education Amendments Act of 1972 ("Title IX") which prohibits discrimination on the basis of sex.

The investigation also included review of the following documents which were either submitted by the complainant, submitted by the school, or accessible via DCPS data systems: 1. Letter (dated 10/16/18) from to and -grade parents addressing "private parts" club 2. Summary of interviews with students conducted by the school social worker **Findings of Fact** The following findings of fact resulted from the investigation: The incident involved students in and grade at during the 2018-19 school year. 2. Social Worker interviewed eights students who were alleged to be part of the "private parts" club. 3. It was reported that _____, Student B, Student C, and Student D were responsible for "inviting" peers to "join" the club. 4. Students reported that the incidents occurred primarily on playdates outside of school and once during a PTA Back to School picnic. 5. It was unclear from the interviews with the eight students if anyone ever exposed their private area to another student; however, all students denied any inappropriate touching by a peer or adult. 6. Each student who was interviewed was provided a "good touch, bad touch" discussion. The grade class and grade class were advised that the "private parts" club was inappropriate and provided a "good touch, bad touch" discussion. 7. When interviewed as a follow-up to this incident, and and indicated that no additional concerns related to this matter were reported to for the remainder of the 2018-19 school year or during the 2019-20 school year. **Discussion/Conclusion** 5-B DCMR 2405.2(e) is unable to be substantiated as a violation of policy. Although administration confirmed that students engaged in the "private parts" club, it is unclear if any student actually exposed themselves to another student. Additionally, all students who were interviewed denied that any inappropriate touching occurred. Ross

appropriate behavior and informing students' parents about the matter. As noted in the letter

took reasonable steps to address the concern by talking with students about

to parents, it is developmentally appropriate for students of this age to be curious about their development. Given this information, this situation does not rise to the level of "severe, pervasive, or persistent" to constitute sexual harassment.

DCPS has taken the following actions below to address this incident:
