RE: Letter of Response for Grievance #3177 filed on May 10, 2019



In accordance with Chapter 24 Subtitle 5-B, Section 2405 of the District of Columbia Municipal Regulations, DC Public Schools (DCPS) Comprehensive Alternative Resolution and Equity (CARE) team has completed its investigation of the above referenced grievance.

Grievance Issues

Based on a review of the information provided, the written grievance raised the following issues under the jurisdiction of this office:

1. On May 8, 2019, you reported that Student A had you against the wall and touched your property, and without your consent while at the state of the Education Amendments Act of 1972 ("Title IX") which prohibits discrimination on the basis of sex.

Investigative Procedure

As a result of this review, we have found that the incident that occurred on May 8, 2019 between and Student A does constitute a violation of Title IX and Chapter 25 of the District of Columbia Municipal Regulations, which governs student discipline. Student A was observed by video camera footage aggressively touching on kissing her, and ignored her request and attempts to have the behavior be stopped. When Student A was confronted in text messages about his behavior, he attempted to persuade to falsify what happened in the room between the two of them.

DCPS has taken the following actions below to address this incident:

- 1. Student A received a Chapter 25, Tier 5 violation as a result of this incident.
- 2. On May 14, 2019, a safety plan was created to support you during the remainder of your final year at
- 3. Effective May 31, 2019, you and Student A are not permitted to be in the same classroom.
- 4. On May 13, DCPS offered to provide you with counseling, however you stated that this was not needed at the time. Should you seek support services, please contact DCPS CARE at the number provided below.

As the complainant, if you are not satisfied with the outcome, you have the right to file an appeal. Appeals must be submitted in writing and received within 10 calendar days of receipt of this notice.
