- To extend the Period of Performance of this emergency contract from September 30, 2023, to October 30, 2023.
- This modification will increase the Period of Performance (POP) from 90 days to 120 days.
- This modification will increase the amount of the contract from \$290,910.00 by \$194,040 to a new total in the amount of \$484,950.
