Question 1:

Accordingly, can you please send me a list of the type of kitchen equipment we would be removing/installing/replacing?

Answer:

Possible equipment may include, but is not limited to: single and double, gas and electric convection ovens, combi ovens, steamers; steam kettles, tilt skillets, dishwashers, exhaust hoods, garbage disposals; cold and hot serving lines, warmers, single and double door refrigerators, milk coolers, dry storage shelving

Question 2:

As mentioned, manpower needed and overall installation costs vary depending on type of equipment, weight, qty of items, the # of schools we will go to, # of trips we make and as well if the final connections needed are to be hard wired by and electrician or are just plug in. Also, if the equipment is gas, will these items need to be hard piped or are they already set up to take quick disconnect hoses?

Answer:

Equipment connections will vary from none to 120v traditional socket, to hard wired gas and electric with a range of watts, volts, amps and phases. Plumbing and electric connections may have to be longer than 5 feet. For example, some steamers may be manual fill and manual drain, while other steamers may require plumbing on intake and outtake of water. If building electrical panel will need additional breakers, we expect the vendor to be able to provide that. If an additional gas regulator is necessary, we expect the vendor to be able to provide that as well. Total number of trips / jobs for the purpose of the quote is 25. DCPS currently has 120 locations where the services might be needed.

DCPS understand that a plug and play 120v warmer is different from a full install of a commercial dishwasher, double combi or serving line. It may be sensible to provide a quote for installing each option from the list above.
