Q&A and Open Mic

- 1. Any thoughts on why math has been more of a challenge area than reading?
 - a. Methods on teaching math have changed over the years and could have impacted how caregivers assisting their students at home during the pandemic.
- 2. How much of the annual budgets are fixed vs. variable? For example, is there true wiggle room to address and course correct inequities?
 - a. Here is a base overview of the Updated Budget Model: https://dcpsbudget.com/budget-model-overview/
- 3. Can you clarify what the parent testimonies should focus on?
 - a. Testimonies can be suggestions for a specific school or programming or generally what the district be prioritizing in funding.
- 4. My interest is in before care and aftercare for all students. I'd like to know how our schools can support academic enrichment through out of school time programs?
- 5. How can we address the inequities in PTO/PTA support across the school district and creating a structure that is a bit equitable to support all schools?
 - a. We want to make sure that DC government does not set the precedence of how parents distribute funds or how they donate their money to PTA/PTO, but we have set up sister schools for PTA/PTOs to support each other.
- 6. Is the funding formula is not just based on enrollment, but also additional criteria focused on need?
 - a. There were three critical factors in developing the updated model: transparency in funding, increasing equity for students, and year-over-year stability for the District.
 - b. Funds are distributed to a school based on its student and staff projections, with additional targeted support provided for students with greater need, while ensuring that schools are provided stability during year-over-year enrollment transitions.
- 7. How much autonomy do school principals have in creating the programming in their schools, for example which languages are chosen at the school?
 - a. Principals have significant autonomy in creating their programming and utilizing their LSAT to do so.



- 8. Is there a shortage of teachers in DCPS? How are you trying to cope with it, being the case?
 - a. We maintain over 90% of our effective and highly effective teachers. This school year, similar to the country's trends, it has been challenging to replace vacancies of retirements and teachers leaving the district.
