

Dear DCPS Family,

We continue to see the strength of our community as we come together during this public health crisis and support the needs of our students. Since learning at home began, our <u>online learning hub</u> on Canvas received nearly 2 million pageviews from more than 80,000 visitors. We also distributed learning at home packets, comprised of more than 3.5 million printed pages, across our district, so that all students have access to learning materials.

These numbers represent parents downloading elementary math lessons, high school students earning credits on the path to graduation, and educators who continue to make their students feel loved, challenged, and prepared as they connect with them virtually across our city. Thank you to all the families, teachers, and community members who are working together to make sure that our students are engaged, supported, and safe.

Technology Access for Students

DCPS is working hard to ensure that families have the resources they need in this unprecedented moment, and we recognize that technology is a critical need for our students to continue their education. I am proud to announce that we are expanding our efforts to support students in need of technology for learning at home.

We will loan devices to families in need as part of our <u>Empowered Learners Initiative</u> (ELi). Distribution of these devices to high school students is already underway. Distribution to middle school students starts this week, and elementary school families will receive devices beginning next week. Your school will send you information on how to pick up a device.

DCPS will loan up to 16,000 technology devices to students to support learning at home. We are also purchasing 10,000 personal mobile hotspots to provide families who need access to high-speed internet while school buildings are closed.

As technology becomes a critical component of our new way of learning, we are also expanding resources available for our youngest students, as well as parents who are adjusting to the pace of learning at home.

For our elementary families, DCPS "Fun with Phonics" lessons are now available on TV every weekday from 9:00 to 11:00 a.m. and then again from 1:00 to 3:00 p.m. These videos are a great way for your student to continue to develop early literacy skills and are available on Comcast (Channel 99), RCN (Channel 18), Verizon (Channel 12), or on the <u>DCPS YouTube channel</u>. I hope that your family tunes in to join our teachers for these exciting lessons.

Suspension of Student Travel

Due to the unprecedented situation the district is facing due to the COVID-19 pandemic, we have come to the difficult decision to cancel all school trips through the summer. All DCPS-sponsored student travel outside the District of Columbia, including DCPS Study Abroad summer 2020 trips, is suspended through July 2020. (This is an update to the previously issued restriction through May 1.)

We know that students were looking forward to these memorable opportunities and travel experiences, but student safety is our top priority. On Monday, March 30, Mayor Bowser issued a <u>Stay at Home Order except in cases of essential</u> <u>healthcare, food, supplies, or employment.</u> Visiting schools to receive meals or learning at home materials is considered an essential activity.
