

In the RFP they mention having 4 copies of the proposal sent but only mention being sent in 2 binders.</p> | <p>Please reference section L.3.1. The RFP proposal requires 4 hard copy versions (binders) and 1 flashdrive. The hard copies should include 1 original and 3 copies (binders).</p> <p>Proposals must be submitted no later than February 14, 2020 by 1:00 pm EST. | 4 | <p>L.8.1 The offeror shall include option year prices in its price/cost proposal. An offer may be determined unacceptable if it fails to include pricing for the option year(s)Vendor support for the items on the bid are normally given for a one year period from July 1st-June 30th. Can you please clarify how option year 2 is to be priced?</p> | <p>Option year pricing may include an estimate for inflation increases utilizing the Department of Labor Consumer Price Index (CPI) for Food Away from Home. It is acceptable to forecast using the previous trends of the CPI and applying this to future pricing.</p> <p>Since this is a requirements contract, the quantities and pricing are estimates and will be evaluated for increases and decreases each option year to ensure the values are aligned with the economic conditions.</p> |
