C.5.3 Testing and Collection Locations

- Pre-Employment Collections and Testing for Employee Applicants and Contractors: All pre-employment testing for employee applicants and contractors should be conducted at any certified laboratory in the United States.
- Reasonable Suspicion and blood alcohol Testing: Reasonable Suspicion specimen collection
 and Blood Alcohol Testing should be conducted at any school site or facility where the employee,
 contractor or volunteer is assigned. Accordingly, DCPS requires a contractor capable of
 dispatching multiple collectors to various locations across Washington, D.C. within two hours of
 the request being made, during a given workday to administer urine collection and Blood Alcohol
 Test (BATs).
- **Specimen Testing**: At a certified laboratory in the United States.
- **Post-accident specimen collection:** At the site of the accident, the school or facility where the employee is assigned or a certified laboratory within Washington, D.C.
- Reasonable Suspicion Training: At any DCPS school site or facility.

C.5.4 <u>Urine Sample Collection</u>

- **C.5.4.1**The contractor shall collect approximately 5,130 urine specimens of employees, applicants, contractors, and volunteers per year; sending specimens to labs for testing and receiving results.
- **C.5.4.2**The contractor shall test urine specimens at a laboratory certified by the Department of Health and Human Services, using the EMIT and GC/MS testing methods.
- **C.5.4.3**The contractor shall verify approximately 5,130 drug test results per year.
- **C.5.4.4**DCPS will require both facility and on-site collection services. DCPS is a school system with over 120 locations throughout the District of Columbia.
 - 1. Facility Collection Needs (Applicants, Contractors, and Volunteers):
 - a. <u>Timeline</u>: DCPS will be performing pre-employment drug tests on applicants and employees, contractors and volunteers in safety-sensitive position beginning in October 2021, and according to the criteria set forth in Section C.4 of the solicitation.

DCPS began performing pre-employment drug tests on applicants in safety-sensitive position beginning in February 2013 and will continue to do so indefinitely.

- b. <u>Number of applicant collections</u>: DCPS anticipates drug testing approximately 5,000 applicants for safety-sensitive positions for the 2021-22 school year.
- c. <u>Service:</u> DCPS will need collector(s) capable of, and licensed/certified to, collect urine samples according to HHS guidelines for approximately 5,000 applicants between October 2021 and September 2022.
- d. Substances tested:
 - I. Marijuana (THC)
 - II. Cocaine
 - III. Opiates
 - IV. Amphetamines
- e. <u>Initial Test</u>: Each urine specimen will be subject to an initial Enzyme-Multiplied-Immunoassay Test (EMIT)
- f. <u>Confirmation Test</u>: If a specimen tests positive for any of the aforementioned substances, the positive result must be confirmed using the Gas Chromatography/Mass Spectrometry (GC/MS) testing method.
- 2. On-site Collection Needs (Employees, Contractors and Volunteers):
 - a. <u>Timeline</u>: DCPS will be conducting reasonable suspicion and post-accident testing in October 2021 and continue through September 2022. DCPS started conducting reasonable suspicion and post-accident testing in October 2013 and will continue indefinitely.
 - b. Number of employees, contractor and volunteer tests:
 - I. DCPS anticipates performing an estimated 100 reasonable suspicion tests during the 2021-22 school year.
 - II. DCPS anticipates performing an estimated 5 post-accident tests during the 2021-22 school year.
 - III. DCPS anticipates performing an estimated 25 follow-up and return-to-duty tests during the 2021-22 school year.

 - I. DCPS anticipates performing an estimated 100 reasonable suspicion tests during the 2021-22 school year.

More than likely our system will be able to be integrated to pull DCPS' database information to auto-populate drug screen requests once a candidate is selected, but all drug screen requests would have to be initiated by an authorized DCPS user/DER.

Candidates are not able to self-request drug tests. Basically, once a DCPS user initiated a drug test for a candidate, the candidate would receive a text/email with instructions on where and when to go for their drug screen (for off-site testing). Is this acceptable?

Answer: Please clarify question - How will this work? Is it a link that can be added to DCPS

"Selected for Hire" email?

Bidder clarification:

Yes, that's exactly how it would work. Through our donor access platform we can

provide a static link that can be placed in email, website, or other electronic

communication that will allow the donor to schedule their own drug test. It just needs to be initiated by DCPS, the candidate can't log into our platform and do it themselves.

Question #4: Just to confirm, there are employees under this contract that are subject to Department of

Transportation drug and alcohol screening regulations?

Answer: No. Employees are not subject to Department of Transportation drug and alcohol

screening regulations.

Question #5: Do I have to be a LSDBE to provide a quote

Answer: No.

Question #6: How many employees are we testing for?

Answer: Section C.5.2 of the Solicitation states, DCPS estimates testing approximately 5,130

individuals per year.

Question #7: Duration of the contract?

Answer: Section F.1 of the Solicitation states, "The term of the base year contract shall be from

October 1, 2021 through September 30, 2022.
