# 4. FACTS WHICH JUSTIFY A SOLE SOURCE PROCUREMENT:

AARP Experience Corps consists of adults 50 and older that provide critical reading and literacy training in elementary schools throughout Washington, DC. The training has been proven to change students outlook toward their academic achievement, which shapes future behaviors towards reading and literacy. Tutors work in small groups to engage learning through a variety of different avenues. Tutors are also able to use the results of the trainings to teachers. Teachers are then able to foster the students' newfound love of literacy and reading, which leads to increased productivity in all areas in the classroom.

# **Program Goals**

- Significant improvement in reading literacy skill with the goal of progressing students toward grade level reading ability
- Increase of student morale and engagement in the classroom
- Tutors provide consistent support to students throughout the academic year
- A senior level team leader volunteer will be placed at each to manage a team of 5 or more tutors. This allows for collaboration and support among peers

# **Outcome Evaluation and Data Source**

Throughout the program, tutors will keep activity logs to monitor their interactions with each student. Each tutor will also produce beginning, mid and end of year reading scores for tutored students. Pre-and-post tutoring assessments will also be given so that student success can be measured accurately. In-an-effort to properly communicate post assessments, teachers are given a program evaluation. This allows the volunteer the opportunity to assist the teacher in developing future-plans for the students continued success.
