## **FINDINGS**

## 1. AUTHORIZATION:

D.C. Code 2-354.04 and 27 DCMR, Section 1304 and 1702

## 2. <u>MINIMUM NEED:</u>

The District of Columbia Public Schools (DCPS,)School Turnaround and Performance Division (STPD), has an immediate need to procure the services of Tandem Conglomerate, LLC to perform operations and maintenance of our School Performance Data Initiative (SPDI) dashboard. SPDI is a web-based dashboard that consolidates and arranges various data points in a single platform so data can be monitored at a glance. The SPDI dashboard is essential for all DCPS schools to provide targeted support to students in addition to supporting school leaders in the monitoring of progress towards their Comprehensive School Plan and IMPACT goals (human capital decisions). DCPS collects a wide range of K-12 data from various data sources and stores the outcome metrics in a SQL database. The frequency of updates to the data varies and is dependent on the metric itself, spanning from weekly to bi-annually.

STPD provides school staff access to SPDI as the system of record for more than 100 priority metrics. SPDI bring s focus to important information, communicates it quickly, and easily, provides visual displays of information needed to achieve one or more objectives, and improve transparency, accountability and ultimately student achievement. DCPS seeks support in the maintenance and development of the front-end website that displays this data clearly for users. Tandem shall provide services in three specific areas: administration and monitoring of SPDI, system support to end users via help desk, and data refresh activities throughout the proposed period of service.

# 3. ESTIMATED COST:

The cost is \$60,000 for the proposed period, beginning at execution of the purchase order through 9/30/2017.

# 3. FACTS WHICH JUSTIFY A SOLE SOURCE PROCUREMENT:

DCPS' School Turnaround and Performance Division within the Office of the Chief of Schools believes it is critical to utilize the services of Tandem in order to accomplish the following goals:

- Conduct multiple "Agile Sprint" design and build sessions that refine and build upon previous work until the system function/module meets the needs and specifications of DCPS.
- Development of Instructional Superintendent's view
- Develop a map view plots of the key metrics
- Develop a summarized map view which can be drilled down to the school level and to the student level detail
- Provide capability to export the data in EXCEL and PDF
- Capable of processing geocode data
- New metrics including : 504 Timeliness, 504 Eligibility Determination, Annual 504 Plan, 504 Suspension, CTE: Industry Recognized Certifications, I-Ready Standards Mastery, School demographics, EDL Proficiency

The abovementioned elements impact every component of the District's Capital Commitment plans which is comprised of 5 goals: Improving Achievement Rates, Improving Proficiency Rates in the LowestPerformingSchools, IncreasingGraduation Rates, ImprovingStudentSatisfaction, and Increasing Enrollment Rates. The five goals within the District's plan all resides in the SPDI dashboard, which provides teachers and leaders with real-time data to aid with course corrections through the school year. Additionally, DCPS has invested millions of federal dollars, Race to the Top funds, to conceptualize the dashboard, which is now in need of continuous maintenance.

### **Background and History:**

Tandem Conglomerate is an Information Technology solutions provider with extensive expertise in a wide range of technical domains. Tandem has experience with project management, database design, and administration to application integration. This vendor also has experience in a variety of industries, from telecommunications to government, and wide-ranging technical expertise, which will be beneficial to the District. Tandem has been working with the District of Columbia Public Schools for 10 years in a variety of technical roles including building, maintaining, integrating and supporting DCPS's variety of administration systems, giving them first-hand knowledge of DCPS' technical environment and business process needs. In SY15-16, STPD partnered with Tandem to revamp and redesign the SPDI dashboard, to make it a truly powerful and useful data tool for school leaders. The goal was to develop a tool that would allow access to data that could be reviewed and analyzed by school leaders, school -based administrators, and Academic Leadership Teams in order to inform instructional, organizational, and programmatic decision-making. As a result of the partnership between STPD and Tandem, the new, dynamic and interactive SPDI dashboard launched at the beginning of the 2016-2017 school year.

Their services are focused on helping to implement, enhance, and efficiently utilize information systems. Tandem's expertise in IT project management, infrastructure services, application integration, and software development was acquired through years of working on large-scale enterprise projects.

#### The Proposed Vendor's Unique Qualifications:

Tandem Conglomerate is an Information Technology solutions provider with extensive expertise in a wide range of technical domains, including technical infrastructure development, application integration, database design and administration, and software development. Tandem has been working with the District of Columbia Public Schools for 10 years in a variety of technical roles including building, maintaining, integrating and supporting DCPS's variety of administration systems, giving them first-hand knowledge of DCPS' technical environment and business process needs.

In collaboration with and directed by STPD's needs and vision, Tandem, designed, built, and deployed a robust architecture for SPDI by performing the full life cycle services to deliver STPD's requirement s. As a result of their work on the SPDI redesign, Tandem has extensive experience with the systems and data interfacing with the SPDI platform. They have previously been granted direct access to the source environment and systems that provide data for SPDI are aware of and understand the business rules that are applied to all accountability metrics, and have the necessary conventions in place to execute all tasks necessary to achieve the goals listed about.

In light of these findings, a sole source award is in the best interest of the SPDI project and would be the most efficient and cost-effective procurement method.

#### Adverse Impact:

It will be cost prohibitive to allow a different vendor that is unfamiliar or have lack the experience with the architecture for SDPI's platform operations and maintenance to provide the operations and maintenance requirements especially as continuity of the existing system is crucial to sustaining and maintaining the goals of STPD).
