

## DCPS Dual Enrollment Opportunities

DCPS high school students have the opportunity to participate in dual enrollment offerings. Through Dual Enrollment, DCPS students can take challenging college courses that are not offered at their home high school, while earning college credit that can be transferred to many postsecondary institutions. Tuition is waived for DCPS students who participate in either of the programs listed below:

### OSSE Consortium Dual Enrollment

### DCPS Private Universities Dual Enrollment

- Accepting applications from DCPS students in grades 11 & 12 with a minimum 3.0 GPA
  - *Rising 11th grade DCPS students can only apply to Howard University*
- Participating Universities:
  - American University - School of Education, American University - Data Science Program, Catholic University, George Washington University, Georgetown University, & Howard University

Each participating college/university sets its own admissions criteria and selection process for dual enrollment students. DCPS serves as the intermediary to facilitate the application process and to provide student support while DCPS students are enrolled in the program. After graduating from high school, participants are under no obligation to continue their academic studies at any participating university.

**Dual Credit:** Students interested in earning both college and high school credits for their Dual Enrollment course can request Dual Credit by using this [form](#). Dual Credit is a component of Dual Enrollment that allows students to earn both high school and college credits. A Dual Enrollment course not taken for Dual Credit does not affect the student's high school GPA, and students will only earn college credit upon successful course completion.

**SY23-24 Program Updates:** Starting in school year 2023-2024, the UDC-CARE Dual Enrollment program has merged with the OSSE Consortium Dual Enrollment program. Students interested in applying to UDC Flagship or UDC Community College should apply to the OSSE Consortium Dual Enrollment Program.

2. After completing Part 1, click “SAVE & CLOSE” to come back to the application later **OR** (if you have all required documents ready) immediately complete Part 2 of the application and click “SAVE & CLOSE”.
3. After all required documents have been uploaded (including counselor/teacher forms), please check the “SUBMIT” box **AND** the “SAVE & CLOSE” button.
  - **NOTE: Checking the submit box does NOT save your application! Please be sure to click “SAVE & CLOSE” to ensure your application is received.**

*NOTE: Program acceptance is valid for the fall and spring semesters of the application year, pending successful course completion. Students who receive a grade of C- or below will be ineligible for the following semester of dual enrollment.*

How to Apply?

- 1. Student Application:** Visit [www.bit.ly/DCPSPrivate](http://www.bit.ly/DCPSPrivate) to complete the online student application.
  - **The application must be completed in one sitting. You will not have the option to save your application and return to it later.**
  - We recommend completing the essay questions in a word document in advance of starting the online application. This will ensure you have time to proofread your essay before pasting into the online application.
- 2. Counselor Recommendation Form:** To complete your application, your school counselor must submit a counselor recommendation form.
  - Please ensure that you give your counselor enough time to complete this portion of the application.
- 3. Letter of Recommendation:** To complete your application, you must include one letter of recommendation from a teacher, principal, counselor, college & career coordinator, or NAF staff.
  - Please ensure that you give your recommender enough time to complete this portion of the application AND verify that materials are received by the deadline.
